

BayLab Grant for Transport Scheme Competition ("Grant Scheme") Terms and Conditions

- 1. BayLab (part of Bayer Plc) is offering schools the chance to be awarded one of a limited number of grants of up to £500 towards travel costs when visiting the BayLab facility in Reading ("Grant").
- 2. The Grant Scheme is open to state funded primary and secondary schools and sixth form colleges in the UK who meet at least one of the following criteria:
 - a. have a low IDACI rank of less than 10,000 (http://imd-by-postcode.opendatacommunities.org/imd/2019);
 - b. have a high proportion of students eligible for free school meals; and/or
 - c. have a POLAR index rating in Quintile 1 or 2.
- 3. The application must be submitted by a member of the school staff who is involved in teaching a STEM subject in the school.
- 4. Applications for the Grant Scheme are free; but only one application per school will be accepted.
- 5. The Grant Scheme is open to apply from 31/05/2021.
- 6. Closing date for applications is 11:59pm on 16/07/2021. Any entries received after this time will not be valid.
- 7. To apply, complete the online application form via, https://forms.office.com/r/mVKBG6nTUU
 - providing an explanation of why BayLab was chosen to suit the requirements of your school/pupils, giving a clear idea of how the school will build upon the experience post visit to maximise its impact and embed any learning into school practice.
- 8. Incomplete or corrupted entries will not be accepted.
- All valid entries will be assessed by a panel, with an independent adjudicator and the successful applicants will be selected based on your explanation of need and impact of visit and data provided
- 10. The successful applicants will be notified by email by the 10th September 2020
- 11. The decisions of the judging panel are final and no correspondence will be entered into.
- 12. The successful applicants must confirm a provisional booking date with BayLab within 3 months of the closing date.
- 13. The Grant is payable, up to a maximum of £500, on production of valid invoices/receipts for transport costs following the school's visit to BayLab.
- 14. Invoices/receipts for transport costs must be submitted to the Promoter within



- 3 months of the visit to BayLab.
- 15. The Grant is for transport costs only and no additional, non-transport costs are included.
- 16. Grants are not transferable or exchangeable and cannot be taken as cash.
- 17. Following your visit to Baylab, you will be asked to complete a short online feedback form about your experience.
- 18. In order to administer this Grant Scheme, the Promoter needs to collect and process certain personal information which may be disclosed for these purposes, to other parties who may provide assistance in this Grant Scheme. By applying, all participants consent to their personal data being used in this manner and for these purposes. The Promoter will retain this information for the administration of Grant Scheme and for twelve 12 months following the date of the visit to BayLab.

- 20. The Promoter has the right to either publish or make available information, regarding those educational institutions who attend BayLab as a result of being awarded the Grant.
